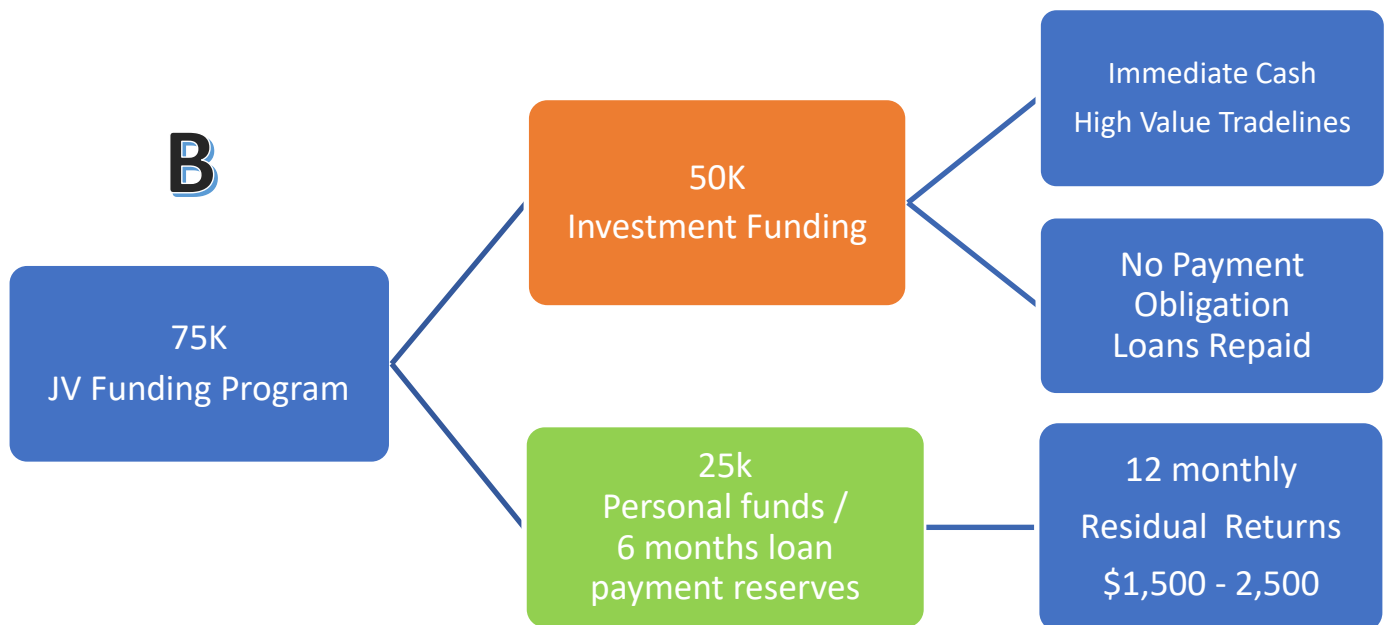
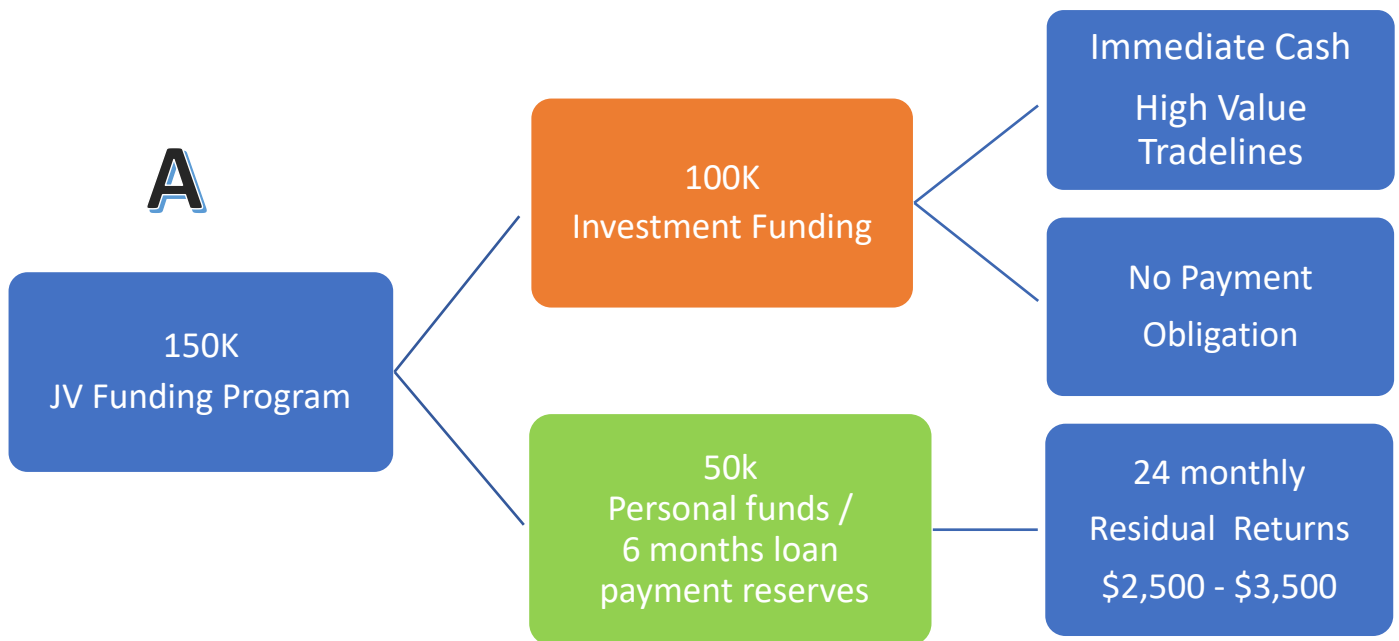
Joint Venture Funding Program

These wholesalers are experienced and established fuel & commodity traders who have been in business for many years, most with contracts already in place. Once acquired these allocations are then sold to end buyers through one time transactions or contractual periods ranging from 1-2 years. Proceeds are used to pay the loans and generate monthly returns for our clients. You the client get to keep your portion of the loan without further commitment to the payment obligation while receiving monthly residual returns.

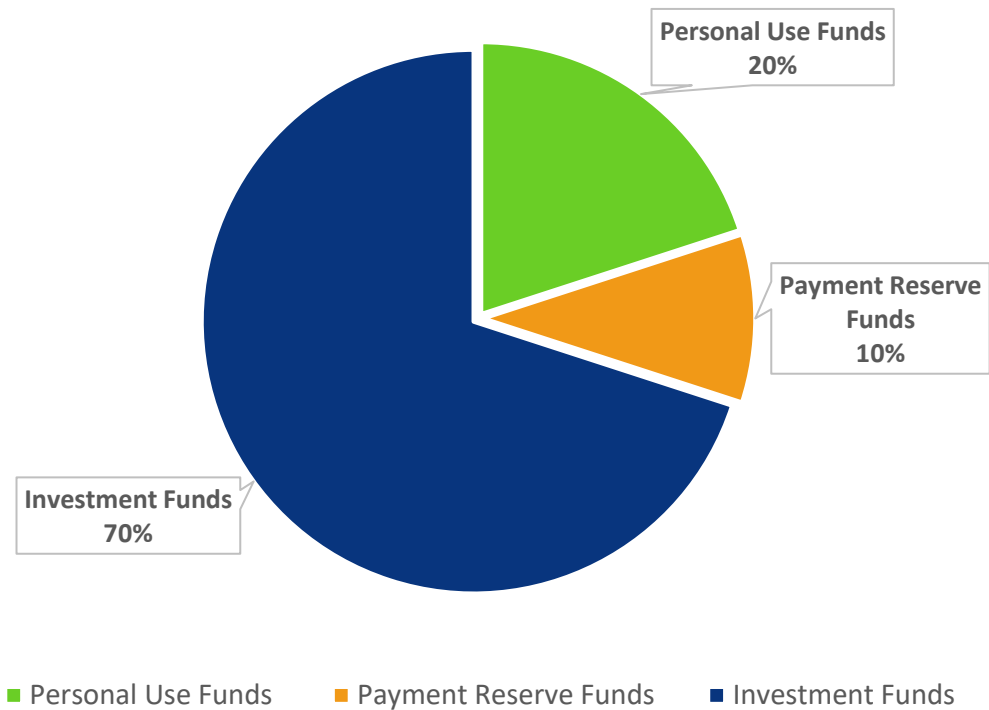
JV Funding Highlights

FREQUENTLY ASKED QUESTIONS

Q. How do I get started?

A. The first step after speaking with our Consultation Specialist is to fill out and return the funding application, along with the login information for your credit monitoring service. After an evaluation we determine if you are ready to move forward or may need some additional credit enhancements.

Q. What are the credit requirements for funding?

A. Minimum credit score 700 on any one credit bureau with at least 3 tradelines 2 of them primaries and a minimum of 1 year history.

Q. How do I know what I'm qualified for?

A. Once the application is submitted our underwriter will submit you for pre-approvals. No hard inquiries are incurred at this time only soft pulls. This will just give you an idea of what you are preapproved for and at how many banks.

Q. What is the time frame for funding?

A. Typically it is between 3-10 days, but it can take longer depending on the client and how quickly you get the necessary documents into the lender.

Q. Do my funds get placed immediately into the investment after funding?

A. No all funds are funds are placed in an escrow account until the minimum our wholesalers require is met, then it is invested as a collective. Typically within the 15-45 days your funds will be placed with one of our wholesale partners to secure a contract.

Q. How long will it take to receive my first monthly payment?

A. Payments occur 15 -20 days after we release funds from escrow to the wholesaler so this time frame can be 30 – 60 after your initial investment.

Q. How is my investment secure?

A. We work only with seasoned established fuel & commodity traders with many years in business. Some of whom sell to large AAA rated corporate buyers, airlines, local and state governments. We invest in contracts to buy and sell fuel and other commodities and as our JV partner you are a party to that contract. This is not subject like other investments to market fluctuations. There is no need to learn to buy, repair and sell property for a one time flip. No hassel of dealing with tenants to recoup a small monthly return on a 30 year mortgage. Once our wholesale partner enters into a contract with the buyer then our returns are set for the duration of the contract.

Q. What paperwork will I receive?

A. As a JV funding partner you will receive a Joint Venture Contract outlining loan repayment schedules, all investment fees, and breakdown of monthly residual payments.

Q. How long before my loans are paid off?

A. Loan repayment is typically within 6 - 12 months. Sometimes shorter.

Q. How are loans repaid?

A. At the time of funding an account will be set up for automatic payments to be deducted. All payments will be sent to the designated accounts.

Q. How will I receive my residual payments?

A. All monthly residual payments will be direct deposited into the account you designate.

Q. Can I have more than one Joint Funding Venture at a time?

A. Yes you can however we encourage investors to be with the program at least 3 months to feel comfortable with the process before we allow for a second JV venture.

Q. How do I get paid as a Broker?

A. As a broker you will receive a monthly commission payment for each client you bring into the program in addition to commission at the time of funding. Your payments will be direct deposited into the account you designate as long as your client is in the program.
